### YVV CHILD SAFE STATEMENT OF COMMITMENT

Children and young people have the right to be safe at all times. This Child Safe Statement has been developed for the protection of children and young people involved in the church community.

Our statement clearly affirms our commitment to:

- Have zero tolerance towards child abuse
- Actively work to listen to and empower children and young people
- Have systems to protect children from abuse, and take all allegations and concerns very seriously. We will respond to them consistently in line with YVV Child Safe Policy and Procedures.
- Commit to promoting cultural safety for Aboriginal children, cultural safety for children from culturally and/or linguistically diverse backgrounds, and to provide a safe environment for children with a disability.

## At YVV....

We believe that churches ought to be places of safety and refuge for children, young people and others, where they should be and feel safe from any threat when on church property or involved in activities operated by the church, or accessing services provided by the church. We believe that the church should be a place where people can disclose abuse and have it dealt with effectively.

All people involved in children and youth ministries have WWCC and undergone careful screening and training, including in the identification and prevention of child abuse. Any disclosures will be handled confidentially, in accordance with our legal obligations under the Child Wellbeing and Safety Act (2005), the Reportable Conduct Scheme (2018), the YVV Child Safe Policy and Procedures, and the YVV Privacy Policy.

We have established and outlined a prevention strategy in our Child Safe Policy and Procedures that includes screening, sound recruitment and selection procedures, clear boundaries, risk identification and management, education, support, supervision and training.
